RESOLUTION OF THE MARGARETTA LOCAL SCHOOL DISTRICT BOARD OF EDUCATION, APPROVING THE ADOPTION OF AN ONLINE LEARNING PLAN FOR THE 2024-2025 SCHOOL YEAR.

The Board of Education for Margarettta Local School District met this 15th day of July, 2024 in Regular Session with the following members present:

Mr. Hula, Mr. Lippert, Mr. Schoenegge, Mr. Sutorius, and Mrs. Tucker.

WHEREAS, the budget bill made changes effective on October 3, 2023 to Ohio's calamity day statute. The budget bill changes replace the use of blizzard bags with online makeup days and requires Districts to adopt an online day plans by Aug. 1 of each year; NOW THEREFORE;

BE IT RESOLVED BY THE BOARD OF EDUCATION FOR THE MARGARETTA LOCAL SCHOOL DISTRICT:

THAT, after careful consideration, a motion was made by Mr. Lippert and seconded by Mr. Schoenegge, that the Board approves the adoption of an online make up day learning plan as presented for the 2024-2025 school year; and

THAT, this Board of Education hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board; and that all deliberations of this Board and of it's committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with the applicable legal requirements, including Section 121.22 of the Ohio Revised Code.



**Margaretta Local Schools
On-Line Learning Plan
2024-2025 School Year**

Margaretta Local Schools plans to make-up instructional time with in-person learning opportunities, however, in the case of an extended shut down the district will offer on-line learning which will have a component of teacher-directed synchronous learning.

- a. Teachers and students will interact through their google classroom which will include some teacher-directed synchronous learning.**
- b. Attendance requirements will be documented by students' engagement in the daily classroom activities and participation through on-line instruction, classroom chat and discussion boards, and assignments turned in through the interaction of the class.**
- c. Students needing assistance from an intervention specialist or other needs including social and emotional supports will be set up with small group or individual sessions to meet their needs.**
- d. The District will send notice of on-line learning through our website, facebook, one call phone system, and Final Form Communications.**
- e. Each teacher will communicate through their google classroom for each class.**
- f. Students or Staff needing connectivity assistance will be afforded temporary connectivity and/or the options for paper and pencil assignments.**

This on-line learning plan was approved by the Margaretta Board of Education at their July 15, 2024 Board meeting.
